Friday April 28, 2017:

The month of April has been designated as Distracted Driving Awareness Month. A four day traffic detail was conducted in four local cities. This was a combined effort between local law enforcement agencies which was aimed towards encouraging overall traffic safety awareness to valley drivers. Here are the traffic statistics.

City of Tulare, Monday April 24, 2017: 108 traffic stops made, 91 citations issued, of the 91 citations issued 25 of those were cell phone violations.

City of Visalia, Tuesday April 25, 2017: 112 traffic stops made, 95 citations issued, of the 95 citations issued 32 of those cites were cell phone violations.

City of Dinuba, Wednesday April 26, 2017: 123 traffic stops made, 107 citations issued, of the 107 citations issued 20 of those cites were cell phone violations.

City of Exeter, Thursday April 27, 2017: 100 traffic stops made, 103 citations issued, of the 103 citations issued 17 cites were cell phone violations.

Tulare, Ca: The month of April has been designated as Distracted Driving Awareness Month and every year in the U.S., almost a half million people are injured or killed in traffic accidents attributed to the combination of texting and driving. The unfortunate truth is distracted driving collisions are 100 percent preventable, because distracted driving is a choice. It is important for drivers to understand that their chances of being involved in a vehicle collision increase exponentially when they choose to drive distracted. Once that decision is made, distracted drivers place everyone on the road in danger. Some of the most common types of distracted driving include: texting, talking on a cell phone, eating, grooming, talking to passengers, operating a navigation system, and adjusting the radio. To combat this issue the Tulare Police Department is teaming up with the Visalia Police Department, Dinuba Police Department, Exeter Police Department, and the California Highway Patrol to conduct traffic enforcement in the city of Tulare. In addition to conducting traffic enforcement in the city of Tulare, Traffic Officers from all the listed agencies will be conducting additional traffic enforcement in each agencies city during the week of April 24th through April 27th as part of the Distracted Driving Awareness Month.

Officers will be looking for distracted drivers and enforcing traffic related laws.
